Sec. 36-69. - Rules for use of the Rusk County Fairgrounds.

Any person who comes on to, uses, travels through or otherwise occupies the Rusk County Fairgrounds shall comply with the provisions outlined in this article.

Sec. 36-70. - Penalty for violations.

Any person violating the provisions of this article shall be fined in amounts as provided in the county fine and forfeiture schedule and, in addition, shall be assessed court costs and assessments that may be applicable which shall be determined by the state legislature from time to time.

Sec. 36-71. - Hours of use.

During daylight saving time the Rusk County Fairgrounds shall be open for use by the public from 6:00 a.m. to 10:00 p.m. During Central Standard Time, the fairgrounds shall be open for use from 6:00 a.m. to 7:00 p.m. During special events for which a usage agreement has been issued the hours which the fairgrounds are open shall be specified in the usage agreement and the fairgrounds shall be open for participants in that activity during periods outside the normal public use hours.

Sec. 36-72. - Littering prohibited.

Section 40-1 is adopted herein by reference and its provisions are incorporated as a rule for use of the Rusk County Fairgrounds.

Sec. 36-73. - Unnecessary noise and offensive conduct prohibited.

No person shall:

- (1) Use offensive language, make unreasonable noise, discharge weapons or fireworks, or engage in offensive gestures or conduct constituting disorderly conduct under state law.
- (2) Disturb other persons in sleeping quarters or in campgrounds between the hours of 10:00 p.m. and 6:00 a.m.
- (3) Cause, create, or contribute to any noise which is broadcast, or caused to be broadcast, into sleeping quarters or campgrounds, or which emits sound beyond the person's immediate campsite, between the hours of 10:00 p.m. and 6:00 a.m., whether by talking, shouting or singing, by using a radio, phonograph, television, or musical instrument, or by operating mechanical or electronic equipment.
- (4) Use electronic equipment, including electrical speakers, at a volume which emits sound beyond the immediate individual camp or picnic site at any time without specific permission of the director.
- (5) Create a disturbance by causing excessive noise by any means.
- (6) Violate section 32-23

Sec. 36-74. - Regulation of pets and other animals.

- (a) Any animal on the fairgrounds shall be leashed unless otherwise constrained in a pen, cage or other device restricting the animal's movement. Leashes shall be no longer than eight feet long. All animal feces shall be collected by the owner or keeper of the animal and removed from the fairgrounds or otherwise disposed of as directed.
- (b) Horses and other livestock are restricted to designated areas north of the north restrooms. All fees must be collected and removed from the fairgrounds or otherwise disposed of as directed by the animal's owner or keeper.

Sec. 36-75. - Advertising prohibited.

No advertising posters, banners or flyers, except poster, banners or flyers that relate to an event or activity currently taking place at the fairgrounds may be posted or displayed.

Sec. 36-76. - Removal of property.

No property owned or in the possession of the county may be removed from the fairgrounds without permission from UW AG/extension committee.

Sec. 36-77. - Fires and smoking regulated.

No campfires, cooking fires or ceremonial fires may be started except in grills or designated fire pits. No smoking or tobacco products are allowed in any building. There shall be no smoking within 20 feet of the entrance to any building located on the fairgrounds.

Sec. 36-78. - Vehicular traffic regulated.

- (a) No motor vehicles shall be operated except on roadways within the fairgrounds.
- (b) Parking of motor vehicles shall be in areas designated for parking.
- (c) Snowmobiles shall be operated only on designated snowmobile trails unless otherwise permitted.
- (d) All terrain vehicles or off road vehicles are prohibited on the fairgrounds without permission from UW AG/extension committee.
- (e) The speed limit on all roadways within the fairgrounds is ten miles per hour.
- (f) Chapters 340 through 350 of the state traffic code, as presently enacted and as from time to time may be amended, are hereby adopted and made a part of the fairgrounds rules by reference.

Sec. 36-79. - Firearms prohibited.

No person shall possess any firearm without written permission from UW AG/extension committee or as otherwise permitted by law while on the fairgrounds premises.

Sec. 36-80. - Glass beverage containers prohibited.

No person shall possess any glass beverage container while on the fairgrounds premises.

Sec. 36-81. - Camping prohibited.

No person shall camp overnight on the fairgrounds premises without written permission. Camping upon the fairgrounds premises shall be limited to the area and for the times specified in the written permission from UW AG/extension committee.

Sec. 36-82. - Alcoholic beverages prohibited.

No person shall possess, dispense, sell or consume alcoholic beverages while on the fairgrounds premises without written permission from UW AG/extension committee.

ARTICLE III. - FAIRGROUNDS REGULATIONS

Sec. 36-83. - Areas open to public use.

No person shall enter any locked building or any building or area of the fairgrounds that may from time to time be designated as closed to the public without written permission from UW AG/extension committee unless otherwise authorized.
